**ORDER: -**

In the G.O.1<sup>st</sup> read above, the Andhra Pradesh Regulation of unapproved and illegal layout Rules, 2007 were issued. Amendments to these rules were issued in the GO's 2<sup>nd</sup> to 15<sup>th</sup> read above and the last date for receipt of LRS applications under these rules was already over by 31.12.2010. Government also decided not to extent the time limit for receipt of LRS applications beyond 31.12.2010.

**2.** The Commissioner, Greater Hyderabad Municipal Corporation, Hyderabad in his report 16<sup>th</sup> read above has stated that the GHMC has received 81,443 applications under Regulation of unapproved and illegal layout rules, 2007 and so far 51,243 applications are disposed off and still there are 30,200 applications yet to be disposed in the matter and they are pending for submission of ULC clearance and payment of final installment of LRS charges to the Greater Hyderabad Municipal Corporation, Hyderabad by the applicants. Further he has stated that the Town Planning Staff are engaged in road widening process relating to III corridors of HMR and also preparation of records relating to census-2011 etc. The Commissioner GHMC has therefore requested the Government to issue orders for extension of time upto 31.12.2011 for disposal of pending LRS applications by Greater Hyderabad Municipal Corporation, Hyderabad.

3. Government, after careful examination of the proposals submitted by Commissioner, Greater Hyderabad Municipal Corporation, Hyderabad decide to extend the time for disposal of pending LRS applications already received by them for a further period of three (3) months i.e from 01.07.2011 to 30.09.2011.

4. Government after careful examination of the matter, hereby issue the following Amendment to the Rule 9 (i) of G.O.Ms.No.902, MA dt: 31.12.2007.

**AMENDMENT**

In the Rule 9 (i) of G.O.Ms.No.902, MA dt: 31.12.2007, for the words "but not beyond six months" shall be substituted with namely "but not beyond 30.09.2011".

4. The above amendment is strictly issued only for disposal of pending LRS applications. No fresh or new application shall be accepted.

5. All the Commissioners of Municipal Corporations / Municipalities and Vice-Chairmen's of Urban Development Authorities are requested to take necessary further action in the matter.
