ORDER: -

In the G.O. first read above as amended from time to time in the G.Os. 2nd to 13th read above, the last date for filing applications under Regulation of unapproved and illegal layout Rules 2007 was extended up to 30.06.2009. However, after careful examination of the proposals submitted by Commissioner & Special Officer, GHMC vide reference 14th read above and several representations received from the public, Government have decided to further extend the time for submitting applications under A.P. Regulation of Unapproved and Illegal Layout Rules, 2007 up to 31-08-2009.

2. Accordingly, the Government in exercise of the powers conferred under Section 455 AA of the Hyderabad Municipal Corporation Act, 1955, Section 218 (A) of the A.P. Municipalities Act, 1965, Section 46(A) of the AP Urban Areas (Development) Act, 1975, hereby issue the following amendments to the Rules issued in the G.O 1st read above as amended in G.Os. 2nd to 13th read above:

In Rule 6 of the said rules for the words “on or before 30-06-2009” the following words shall be substituted, namely:

“On or before 31-08-2009”
