2. Accordingly, the Government in exercise of the powers conferred under Section 455 AA of the Hyderabad Municipal Corporation Act, 1955, Section 218 (A) of the A.P. Municipalities Act, 1965, Section 46(A) of the AP Urban Areas (Development) Act, 1975, hereby issue the following amendments to the Rules issued in the G.O 1st as amended in G.Os 2nd 4th to 8th and 10th read above :

AMENDMENT

In Rule 6 of the said rules for the words "on or before 31-01-2009" the following words shall be substituted, namely:

"On or before 30-04-2009 "

The surcharge conditions on penal amount mentioned in the G.O. 10th read above shall holds good.
